This year also brought sorrow with the passing of Tony Whitford, a former Sergeant-at-Arms, Speaker and Commissioner. He was a cherished figure in our territory's political and cultural life. Tony's legacy of warmth, humour, and unwavering dedication to public service continues to inspire us. We honour his memory and the path he helped pave for future generations.

It remains my honour to serve as Speaker, and I will continue to foster respectful dialogue, cultural inclusion, and meaningful engagement. The Legislative Assembly is not just a building—it is a living institution shaped by the people it serves. I look forward to continuing this journey with all of you.

The Standing Committee on Accountability and Oversight is the body where all 11 Regular Members come together to coordinate sessional business and Committee strategic initiatives. This Committee also reviews issues which have government-wide implications. This fiscal year, Committee performed reviews of the Main estimates and Infrastructure Acquisition Plan. In collaboration with Cabinet, AOC expedited its review of the *Northwest Territories Indigenous-Led Conservation Fund Establishment Act* in order for the legislation to receive assent during the October 2024 sitting.

Committee began to work together to finalize all Standing Committee Terms of References while engaging in a variety of internal briefings to better understand departmental operations and key policy initiatives which will support the advancement of the priorities of the Assembly.

The Standing Committee on Economic Development and Environment Committee consists of no more than 6 regular members and 3 regular member alternates. The Committee sets out to:

- Review multi-year business plans and budgets, bills, boards, and agencies, including the Workers' Safety and Compensation Commission of the Northwest Territories and Nunavut, the Northwest Territories Power Corporation, the Northwest Territories Business Development and Investment Corporation, and the Public Utilities Board;



- Review departmental performance, including that of boards and agencies;
- Consider matters related to economic affairs;
- Consider matters related to public infrastructure;
- Consider matters related to energy policy;
- Consider matters related to environment and sustainability development;
- Consider any other matter referred by the House.

This fiscal year, Committee set out to review the NWT Land Use Permitting and Water Licensing Regulatory Framework. Committee reviewed the underlying processes and requirements under the *Mackenzie Valley Resource Management Act* (MVRMA), their interpretation by all parties, with the goal of ensuring the spirit and intent of the MVRMA is being met, and to assess the Government of the Northwest Territories' role in the system.

Committee built upon other complementary initiatives such as the Mackenzie Valley Operational Dialogue, the NWT Environmental Audit, and other work already done by the Land and Water Boards, Indigenous governments, the GNWT, the Government of Canada, and stakeholders who interact with the land and water use permitting and licensing processes.

In January, Committee held a public hearing, reviewing **Bill 11: An Act to Amend the Motor Vehicles Act**. This review was aimed to:

- Protect consumers purchasing used cars from false vehicle histories
- Help government agencies track statistical information about the NWT population
- Reduce fraud by non-residents claiming to live in the NWT
- Reduce red tape and administrative burden for the Registrar's office.

The public hearing was followed by a clause-by-clause review on February 13, and assent of **Bill 11** was received on March 13, 2025.

In September 2024, Committee travelled to Hay River to attend the opening of the Hay River Fish Plant. Committee Members attended the opening of the Hay River Fish Plant, toured the Marine Transport Services Facility and Syncro-lift, and visited the Western Arctic Marine Training Centre. Committee Members had the opportunity to meet with the K'atl'odeeche First Nation, Mayor of Hay River, and local entrepreneurs.

This fiscal year, the Committee completed a statutory review of *Cannabis Legalization and Regulation Implementation Act* and began its statutory review of the *Northwest Territories Heritage Fund Act*, which it is scheduled to complete in early 2026.

Committee studied the 2022-23 and 2023-24 annual reports of:

- The Northwest Territories' Equal Pay Commission
- The Information and Privacy Commission
- The Official Languages Commission
- The Office of the Ombud
- Human Rights Commission

The Committee studied the Government's Indigenous Employment Policy, received updates related to various Government initiatives and the Northwest Territories Power Corporation.

In response to a referral from the Speaker, the Honourable Shane Thompson, Committee conducted a review of Rules. The Committee considered the concerns and made recommendations to the Assembly. The Report on the Review of the Rules of the Northwest Territories Legislative Assembly was considered in Committee of the Whole in February 2025, all recommendations were carried. The changes to the Rules ensure consistency, predictability, and efficiency in sessional proceedings.

INTERIM REPORT ON THE REPORT OF THE CHIEF ELECTORAL OFFICER ON THE ADMINISTRATION OF THE 2023 TERRITORIAL GENERAL ELECTION.

Pursuant to subsection 266(2) of the *Elections and Plebiscites Act*, the Chief Electoral Officer (CEO) must report on the administration and event initiatives seen through that office within six months following a Territorial General Election. The report has any matters the CEO thinks should be brought to the Legislative Assembly's attention. It also includes recommendations on how to improve election administration alongside any suggested amendments to the Act.

- The Speaker tabled the CEO's report on May 21, 2024 in the Legislative Assembly and was subsequently referred to the Standing Committee on Procedure and Privileges (Committee) for review and response.
- SCOPP reviewed the report of the CEO, sought public feedback on the report and held a public hearing on the report, which included appearances from the CEO Mr. Stephen Dunbar and Deputy Chief Electoral Officer Ms. Charlotte Digness. Mr. Aleks Toiviainen of Vote16 Canada also presented to Committee.
- Committee made two recommendations to the Assembly: that the Legislative Assembly direct the Chief Electoral Officer to undertake a repeal and replace of the *Elections and Plebiscites Act* before the end of the 20th Assembly; and that the Legislative Assembly direct the Chief Electoral Officer to engage with the Northwest Territories Association of Communities to determine how to better support local authority election activities.
 - » Report on the Review of the Chief Electoral Officer's Report on the Administration of the 2023 Territorial General Election – February 2025
 - » Further to their October 2024 Interim Report on the Report of the Chief Electoral Officer on the Administration of the 2023 Territorial General Election, Committee delivered a report specifically on the CEO's recommendation to lower the voting age in the Northwest Territories to 16.
- Committee recommended that the Speaker refer the broader matter of low voter turnout in the Northwest Territories to the Standing Committee on Procedures and Privileges to be studied and reported on. This work has continued into the 2025-26 fiscal year.

During the 2024-25 fiscal year, the Committee completed its review of the 2022–2023 Public Accounts, and began its review of the Public Accounts for the following 2023-2024 fiscal year. The Committee also began its review of the Office of the Auditor General of Canada's audit report of the Stanton Territorial Hospital Renewal Project, holding a public briefing with the Deputy Auditor General and the deputy ministers of the Departments of Finance, Infrastructure, and Health and Social Services.

The Standing Committee on Social Development Assembly presented three Committee Reports to the Assembly during the reporting period:

- Report on **Bill 2: Missing Person's Act**
- Report on **Bill 8: An Act to Amend the Student Financial Assistance Act**
- Report on the Statutory Review of the *Mental Health Act*.

The Committee received direction by way of motion in the House on February 28, 2024 to undertake a study of the implementation of housing as a fundamental human right within the laws of the Northwest Territories and policies of the Government of the Northwest Territories. Between August 2024 to March 2025, SCOSD engaged the public to inform their study, and held 15 public briefings from various stakeholders.

The Committee also undertook a study on Healthcare Accountability and Sustainability to understand how healthcare in the Northwest Territories can remain sustainable and accountable to the goals of improving the quality of care and life, and wellbeing of residents and healthcare staff in the Northwest Territories.

In April 2024, as part of its review of **Bill 2**, the Committee travelled to the communities of Inuvik and Aklavik and held public meetings about the legislation. During these travels Committee had the opportunity to visit the Inuvialuit Regional Corporation's Reindeer Station, the Gwich'in Tribal Council's Gwich'in Wellness Camp, the Children's First Society, and Inuvik's RCMP detachment.

In March 2025, **Bill 23: An Act to Amend the Children's Law Act** and **Bill 24: An Act to Amend the Family Law Act** were referred to Committee for review.

The establishment of the Board emphasizes the responsibility that Members have for the general administration of the Legislative Assembly and confirms the independence of the Legislature from the Executive branch of government.

The Speaker has the primary responsibility for the services and programs required by the Assembly and its Members. Its responsibilities include, but are not limited to:

- Compiling and approving the annual budgetary estimates for the operation of the Legislative Assembly
- Reviewing Legislative Assembly expenditures
- Arranging for adequate space for the Assembly operation
- Establishing the organization and staff of the Legislative Assembly
- Administering the indemnities, allowances, expenses and benefits to Members
- Setting the regulations and policies for all services to be provided to Members.

All Members of the Legislative Assembly (MLAs) form the Caucus, which ensures the success of consensus government in the NWT. Caucus allows all MLAs, regardless of their roles, to work together on broad strategic goals and pressing issues facing the territory.

Caucus meetings are confidential, fostering open, honest discussions without the constraints of Cabinet or committee solidarity. Even the Speaker and Premier contribute as equal participants unless they're required to speak in their official capacities.





STATUTORY OFFICERS

2024-2025

Statutory officers (also called independent officers) play an important role in helping Members hold the government accountable. They help Members assess government programs, investigate complaints, examine procedures, and monitor performance. Statutory officers serve for fixed terms that vary according to the laws governing each position. These officers are appointed by, and report to, the Legislative Assembly.

THERE ARE SEVEN STATUTORY OFFICERS OF THE NORTHWEST TERRITORIES LEGISLATIVE ASSEMBLY:

OFFICE OF THE CHIEF ELECTORAL OFFICER

Elections NWT conducts and administers general elections, by-elections, and plebiscites in the Northwest Territories. Its principal mandate is to educate, inform and empower all eligible electors and candidates in the Northwest Territories to exercise their democratic rights outlined in the Canadian Charter of Rights and Freedoms, so that they may participate fully in the election process.

OFFICE OF THE HUMAN RIGHTS COMMISSION

The *Human Rights Act* came into force on July 1, 2004. The Act recognizes that in the Northwest Territories every individual is free and equal in dignity and rights, without regard to their race, colour, ancestry, nationality, ethnic origin, place of origin, creed, religion, age, disability, sex, sexual orientation, gender identity, marital status, family status, family affiliation, political association or social condition and without regard to whether he or she has had a conviction for which a pardon has been granted.

OFFICE OF THE EQUAL PAY COMMISSIONER

The right to equal pay for work of equal value is created by section 40 of the *Public Service Act* and applies to public service employees. It requires that there be no differences in the rate of pay between male and female employees who perform work of equal value in the same establishment. The Equal Pay Commissioner receives complaints from employees who believe that their right to equal pay for work of equal value has been violated.

OUTREACH: PAGE PROGRAM

In 2024–2025, the Legislative Assembly continued to welcome youth from across the Northwest Territories through the Page Program, which provides students in Grades 7 and 8 with a front-row seat to how public policy is shaped in the Chamber. Pages are selected on a rotational basis from schools in each constituency, offering broad territorial representation and a memorable civic education experience.

This year introduced several new program enhancements, including the Meet Your Member Luncheon—a meaningful opportunity for Pages to connect directly with MLAs, share stories, and learn about the roles and responsibilities of Members. In addition, all page group photos and photos with MLAs are now uploaded to an online photo system, making it easy for Members and participants to share their experience. Weekly social media spotlights showcase each group of Pages by region and sitting week, further celebrating their involvement and encouraging other youth to apply.

OUTREACH:

YOUTH PARLIAMENT

The 2024 Youth Parliament brought together 19 students from across the Northwest Territories from April 23-25 for an immersive, 3-day-long experience at the Legislative Assembly. Representing 19 Electoral Districts, the participants—students in Grades 9 and 10—stepped into the role of MLA, learning firsthand about Consensus Government, the legislative process, and the responsibilities of elected officials.

The week concluded with a formal mock session held in the Chamber. The session was ceremonially opened and closed by Former Commissioner, the Honourable Margaret Thom. In a historic first, the Honourable Speaker Shane Thompson presided over the proceedings in his official capacity as Speaker. The program provided not only political education but also an opportunity for youth to build confidence, make connections, and explore what it means to lead and serve in the North.

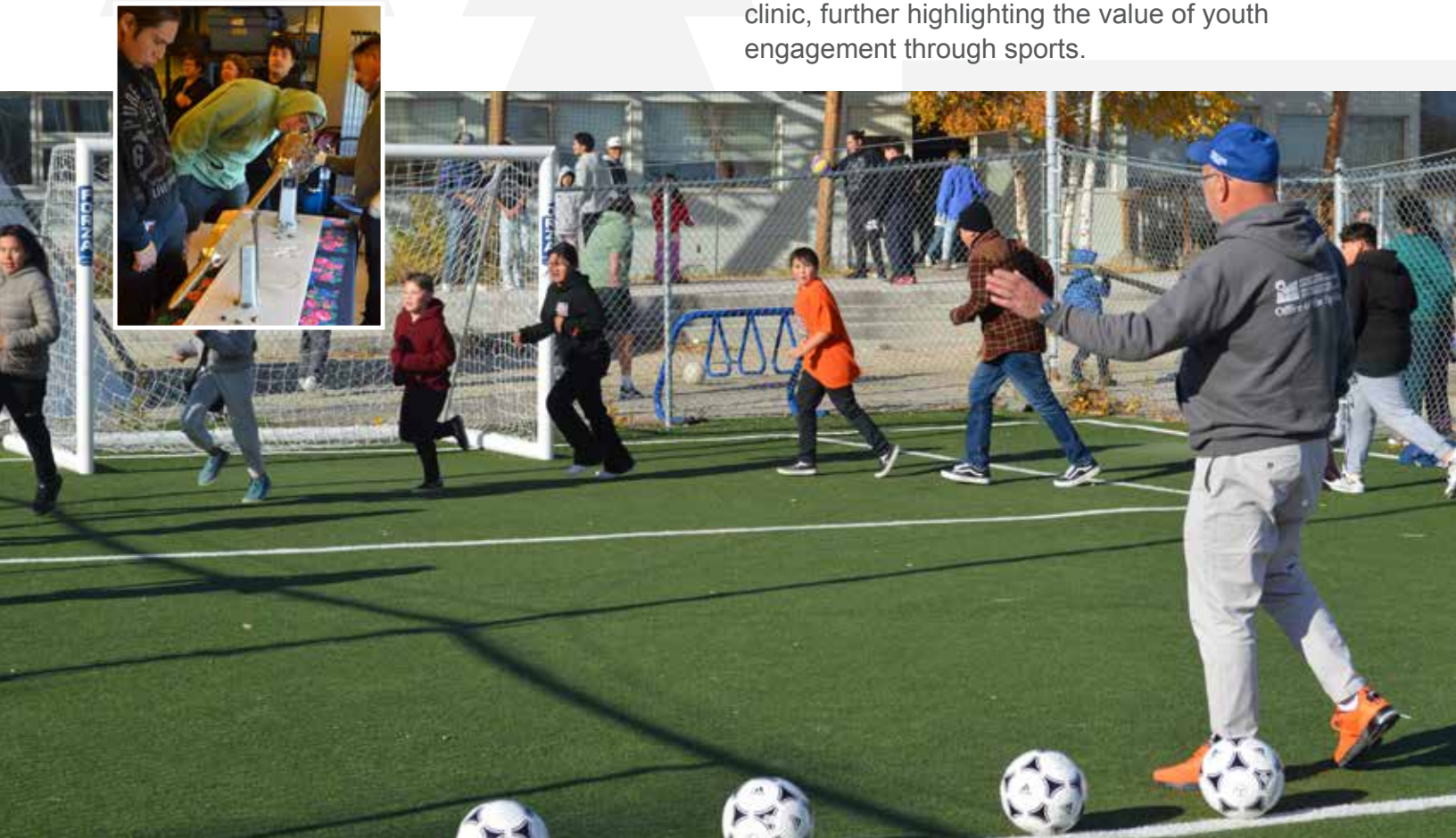




OUTREACH: MACE TOUR

The 2024 Mace Tour continued its mission of connecting communities with the Legislative Assembly. In October of 2024 the Mace Tour traveled to N'Dilo. Led by Speaker Shane Thompson, the tour offered students and community members a chance to engage with the Mace—a powerful symbol of governance, culture, and unity in the Northwest Territories.

The Mace, which incorporates carving, metalwork, beadwork, quillwork, and pebbles from all 33 NWT communities, was at the heart of this experience, sparking discussion and pride. By bringing the Mace to the people, the tour reinforced the importance of presence, tradition, and youth engagement across the territory. Speaker Shane Thompson further engaged with students by leading a soccer clinic, further highlighting the value of youth engagement through sports.





OUTREACH:

KINDER CHRISTMAS

A long-standing and beloved tradition, the Kinder Christmas Program once again welcomed students to the Legislative Assembly building in December 2024. Since its inception in 1993, this annual event has brought joy and excitement to students, teachers, and staff alike.

Kindergarten classes from Yellowknife, Dettah, and Ndilq were invited to decorate Christmas trees in the Great Hall, each student contributing handmade ornaments—many of which this year were made with popsicle sticks and other creative, festive materials. As always, the result was a dazzling display that brightened the building and uplifted all who visited during the holiday season.

The program continues to foster a spirit of inclusion and celebration, bringing young learners into the Legislative Assembly in a joyful, welcoming way while connecting them with the space and the people who work within it.

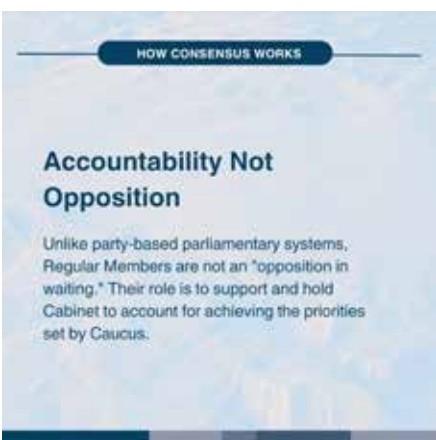

INITIATIVES:

CONSENSUS GOVERNMENT AD CAMPAIGN

In March 2025, the Legislative Assembly launched a digital outreach campaign highlighting the **11 Guiding Principles of Consensus Government**, as outlined in the 2020 Guiding Principles and Process Conventions document. Each principle—from Working Together, Uniting Traditions, and Caucus: Talking Together to Conflict Not Confrontation—was adapted into bite-sized, accessible social media content designed to inform or remind residents and Members about the NWT's unique system of government.

The campaign aimed to demystify the roles of Regular Members versus Cabinet, clarify the purpose of Caucus, and increase public understanding of how decisions are made collaboratively in a non-partisan model. By sharing the core values that guide the Legislative Assembly—like open communication, mutual respect, and active participation—the initiative worked to strengthen awareness and reinforce the importance of consensus in the NWT's governance.



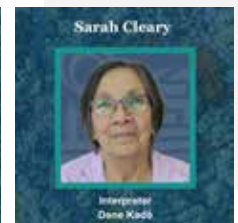
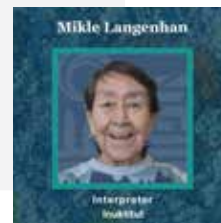
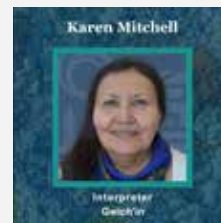


INITIATIVES: OFFICIAL LANGUAGES
