MLA Reid moved that Bill 22 be amended by deleting paragraph 18(2)(a) and substituting the following:

(a) certify, in accordance with subsection (3), a copy of each Act enacted by the Legislature, including any revised Act that receives assent under subsection 41(3), as soon as practicable after receiving a copy of the Act under subsection (1) and on satisfying themselves that the copy accurately reflects the Act as enacted by the Legislature;

Carried.

MLA Reid moved that Bill 22: Legislation Act as amended be reported to the Assembly as ready for consideration in Committee of the Whole. Carried.
