






2025 Calving Ground Surveys

Aerial count of female caribou on calving ground (visual and photo surveys)











Bathurst Herd: 2025 Calving Ground Survey




Bathurst Herd: 2025 herd estimate



Year	Estimate	95% CI
2021	6,243	(3,950-9,134)
2022	6,851	(3,895-12,050)
2025	3,609	(3,203-4,067)




Bathurst Herd: Other Key Information




- Survey results suggest a herd decline, but not the magnitude observed between the 2022 and 2025 surveys
- High winter overlap of Bluenose-East,
 Bathurst and Beverly herds since 2021
- Increased movements of collared cows to neighbouring calving grounds
- Continue to look at data on cow, calf, and bull survival


Bluenose-East 2025 Calving Ground Survey




Bluenose-East Herd: 2025 Herd Estimate



Year	Estimate	95% CI
2021	23,202	(19,247-27,971)
2023	39,525	(33,021-47,310)
2025	28,759	(25,997-31,816)



Bathurst No-Hunting "Mobile Zone"



- Established via Regulation Mobile Core Bathurst Management Zone (2015)
- Complete harvest closure within Zone
- Zone Maps are updated and posted weekly
 - Based on current and anticipated Bathurst Caribou Locations (Collared Caribou data)
- MCBMZ Compliance Violations
 - 2023/24: 0 caribou
 - 2024/25: 2 caribou



Tibbitt to Contwoyto Winter Road Compliance, Monitoring & Enforcement

Mission

• Promote wildlife conservation and sustainable management by monitoring and enforcing compliance with territorial regulations.

Objectives

- Maintain a Visible Education and Enforcement Presence
 - Up to 5 Renewable Resource Officers
 - 2 Patrol Stations (Gordon Lake & McKay Lake)
- Maintain High Compliance with the Wildlife Act & Mobile Core Bathurst Management Zone Regulations
- Ensure Fair & Defensible Investigations
- Facilitate Seamless Coordination

 - Tłicho Government,
 - Yellowknives Dene First Nation
 - North Slave Métis Alliance
- Caribou Guardians Coalition








Respected Harvesters Meetings

- December 2021, January 2022, August and November 2025
- Recommendations on how to encourage safe and respectful harvesting
 - Work together and increase communication and public awareness
 - Increase coordination amongst monitor and guardian programs
 - Share statistics on illegal and disrespectful harvesting



Next Steps

- Continue working with co-management partners on caribou monitoring, conservation and recovery actions
- Meet with Indigenous government-led monitoring programs to prepare for the 2026 winter road season
- Maintain collaborative public education and awareness efforts to promote safe, legal and respectful harvest
- Maintain GNWT-led compliance and enforcement efforts
