#### SECOND SESSION OF THE NINETEENTH LEGISLATIVE ASSEMBLY

# May 27, 2021

The Assembly commenced sitting at 1:31 pm, with the Honourable Frederick Blake Jr., Speaker, presiding.

The Assembly observed a moment of silence in recognition of the passing of His Royal Highness, Prince Phillip, the Duke of Edinburgh.
